

## **HONG KONG-SHENZHEN INNOVATION AND TECHNOLOGY PARK LIMITED**

### **Invitation for Expression of Interest (EOI) for use of storeroom(s) at different designated locations at Hong Kong-Shenzhen Innovation and Technology Park (HSITP) for storage purpose**

#### **Introduction**

Hong Kong-Shenzhen Innovation and Technology Park Limited (**HSITPL**) is now inviting existing commercial tenants who operate business at HSITP to express your interest in the use of the storeroom(s) at different designated locations at HSITP for storage purpose.

#### **Description of Works**

HSITP covers an area of approximately 87 hectares and the development is divided into two phases. The estimated total floor area of the first phase will be approximately 1 million square meters, which will provide research and development (wet lab / advanced manufacturing) buildings, dry lab / office buildings, research, academic and industry buildings, talent accommodation, visitor lodges, commercial and ancillary facilities, etc. Apart from Batch 1, the remaining land in the first phase of HSITP will be developed through enterprises investment, aiming to enhance the speed and quantity of project development by leveraging market forces to build high-quality research and industrial infrastructure.

Currently, Batch 1A consists of the first 3 buildings that were completed in 2025. Meanwhile, HSITPL is planning to carry out the licensing of various storerooms for storage purpose to support the commercial operation of Batch 1A.

#### **Eligibility Criteria**

The applicant should be an existing commercial tenant who operates commercial business at HSITP, including but not limited to retail and F&B.

#### **Facilities to Be Provided by HSITPL**

HSITPL will provide storage space at designated location(s) for storage purpose.

#### **Obligations of the applicant**

1. The applicant shall use only the storeroom(s) earmarked to store certain items in connection with the operation of its business at HSITP as may be permitted by HSITPL from time to time and shall not use such storeroom(s) for any other purpose.
