Works Description:

The Scope of Works of the ICT System includes but not limited to Communication Services, Network System, WiFi System, Network Security and Structured Cabling System for a 10-storey single building with a basement level.

This building will accommodate dry laboratories, offices, higher education facilities (including teaching spaces), MICE enabled facilities, and commercial and ancillary facilities such as retail, dining, sports, and entertainment. Information and Communication Technology (ICT) System and Structured Cabling System (SCS) would be designed and adopted for the above building.

Shortlisting Criteria:

- (a) At least two contracts for the provision of ICT system works completed in Hong Kong within the last 5 years of final contract value not less than HK\$5 million.
- (b) At least two contracts for the structured cabling system works completed in Hong Kong within the last 5 years of final contract value not less than HK\$3 million.
- (c) The Contractor should be certified by the Structured Cabling System supplier, demonstrating one or more of the following certifications:
 - (i) Certified Installer of Structured Cabling System issued by the Structured Cabling System supplier.
 - (ii) BICSI Certificates, including BICSI Registered Communications Distribution Designer® (RCDD®), BICSI Installer 2, BICSI Technician® (TECH™) Certification.

Submission Requirements:

Interested company is required to submit **1 set of hard copy and 2 sets of soft copy (CD)** of the **Proforma for Shortlisting and supporting documents** in a sealed envelope within the date and time for submission stated below. Returning envelope shall be clearly marked as per the template shown in the **Notes for Applicants**.

Date and Time for Submission:

Closing date and time for submission are **02 October 2024, 12:00 noon**. Interested company shall submit their Proforma for Shortlisting and supporting documents **between 9:00am to 12:00 noon of 02 October 2024**. Late submissions will **NOT** be entertained. In the event a tropical cyclone warning signal No. 8 or above is hoisted, or a black rainstorm warning signal or “extreme conditions after super typhoons” announced by the Government is in force between 9:00 am and 12:00 noon on the submission closing date, the submission deadline will be **postponed to 12:00 noon** on the next working day.
