# **Works Description:**

The scope of works shall be described as follows and on the Tender Drawings, including but not limited to design, supply, and installation of below notable components for a 10-storey single building with a basement level:

- (a) Utilized curtain wall system with inclined fins
- (b) Window
- (c) Aluminum cladding
- (d) Aluminum AC grille
- (e) Architecture louvers
- (f) Metal soffit
- (g) Sliding/bi-fold door system
- (h) Glass balustrade
- (i) Glass wall with fins
- (j) Ceiling soffit
- (k) Other system related to façade and requested by the Client in bidding quantity list.

Details demarcation refers to the Architect's drawing.

This building will accommodate dry laboratories, offices, higher education facilities (including teaching spaces), MICE enabled facilities, and commercial and ancillary facilities such as retail, dining, sports, and entertainment. Façade area of the tower level is approximately 5,000 square meters and façade area of podium level is 4,000 square meters.

### **Shortlisting Criteria:**

- (a) At least one contract for window wall / curtain wall works completed in Hong Kong within the last 5 years of final contract value not less than HK\$100 million.
- (b) Sufficient experience of unitized curtain wall system in Hong Kong within the last 5 years.
- (c) Successful performance on comparable façade projects in Hong Kong within the last 10 years.
- (d) Sufficient plants owned by the contractor or approved suppliers for all fabrication and finishing works.
